NOTICE OF MOTION BY CO-LEAD COUNSEL
FOR AWARD OF FEES AND EXPENSES

PLEASE TAKE NOTICE that, on November 10, 2016 at 2 p.m. at the United States District Court for the Southern District of New York, 500 Pearl Street, Courtroom 26B, New York, New York, upon the accompanying Memorandum of Law and Declarations of Jennifer R. Scullion, Marta Colomar-Garcia, and Saul Roffe (and the exhibits thereto), and all pleadings, arguments, and prior proceedings, the undersigned Co-Lead Counsel in these actions (“Co-Lead Counsel”) will move this Court for an order, pursuant to Federal Rules of Civil Procedure 23 and 54, for (i) an aggregate award of attorneys’ fees to Co-Lead Counsel in the amount of \$35,387,938.50 or 33.3% of the total amount paid by Argentina under the Settlement Agreement, whichever is lower, (ii) an award of \$914,513.80, plus interest, as reimbursement for costs and expenses incurred by Co-Lead Counsel in prosecuting these cases, and (iii) any and all further relief that the Court deems just and proper.

PLEASE TAKE FURTHER NOTICE that objections, if any, are due October 21, 2016 and replies are due November 1, 2016.
