I, Marta Colomar-Garcia, pursuant to 28 U.S.C. § 1746, hereby declare and state as follows:

1. I am a partner at Diaz, Reus & Targ, LLP.
2. My firm is co-lead counsel for the Plaintiffs in the eight class actions listed above.
3. Amongst other tasks, my firm has, alone or in conjunction with the other co-lead counsel, (a) investigated and discussed the facts with the class representatives; (b) kept the class representatives informed of the status of the class actions; (c) moved for and obtained a temporary restraining order against Argentina despite its opposition (d) objected to Argentina's 2010 Exchange Offer; (e) propounded and responded to written discovery, including collecting and producing client documents; (f) moved to obtain writs of attachment; (g) prepared expert reports on continuous holder and damages issues, and prepared and defended the expert witnesses during deposition; (h) moved for and obtained judgments from this Court in all eight cases over Argentina's opposition; (i) moved to accelerate the class bonds over Argentina's opposition, later affirmed on appeal; (j) moved to modify the class definitions over Argentina's opposition, later reversed on appeal; (k) briefed and argued before the Second Circuit in several appeals; (l) prepared and disseminated class notice and administered opt out process; (m) prepared and disseminated Request for Proof of Claims and administered the Proof of Claim process; (n) drafted briefs on multiple occasions seeking an extension of the pari passu injunctions to the eight classes and in opposition to Argentina's request to vacate the pari passu injunctions; (o) negotiated and worked on the Settlement Agreement and Motion for Preliminary Approval; (p) prepared the Notice and Summary Notice of Settlement and worked with the claims administrator (Gilardi & Co.) to disseminate the notices of settlement; (q) reviewed the

Settlement Claim Forms and supporting materials, and responded to innumerable telephone conferences and emails with individual claimants.

4. The schedule attached hereto as Exhibit "A" is a summary indicating the amount of time spent by each attorney and professional support staff of our firm who were involved in the prosecution of these cases. Exhibit "A" was prepared from contemporaneous daily time records regularly maintained in my firm. Time expended in preparing this application for fees and reimbursement of expenses has not been included in this request. Our firm has not received any compensation from the class representatives or from any member of the classes for the prosecution of this Litigation.

5. The hourly rates for the attorneys and support staff in our firm included in Exhibit "A" are the same as the regular rates charged for their services in non-contingent matters and/or which have been accepted in other securities litigation.

6. The total number of hours expended by our firm on the prosecution of the Litigation through September 30, 2016, is 7,947.2 hours. The total lodestar for our firm for those hours is \$4,426,182.00 as shown in Exhibit "B."

7. Our firm's lodestar figures are based upon the firm's billing rates, which rates do not include charges for expense items. Expense items are billed separately and such charges are not duplicated in our firm's billing rates.

8. As detailed in Exhibit "B," our firm has incurred a total of \$230,610.58 in unreimbursed expenses in connection with the prosecution of the Litigation. The expenses incurred are reflected in the books and records of our firm. These books and records are prepared from expense vouchers, and receipts, check and wire transfer records, and other source materials and are an accurate record of the expenses incurred.

9. Furthermore, the undersigned has located a document, attached as Exhibit "C", that appears to reflect time incurred by attorney Guillermo Gleizer in the above-referenced matters from 2003 to 2009. However, because Mr. Gleizer joined and left our firm in 2010, the undersigned is unable to attest to the veracity of those time entries.
