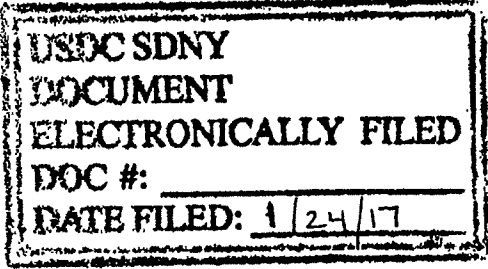


ORDER

On November 10, 2016, the court held a fairness hearing in the above captioned cases to address proposed settlements. At the fairness hearing, plaintiffs requested an extension of the deadline for submission of class members' claims and documentation to the Republic of Argentina. The court extended the deadline to November 15, 2016.

The court now invites plaintiffs in these cases to file an updated list of claims submitted, and the corresponding anticipated value of the class fund and attorneys' fees requests. The court also requests that class counsel submit further supporting documentation regarding their pending attorneys' fees requests, including a detailed statement of how the attorneys' hours were spent. All plaintiffs' submissions are to be filed by February 13, 2017. The Republic of Argentina may submit a reply no later than February 23, 2017.
